
## Seeking Director Candidates in Districts 2, 3, and 8

BCREA is seeking member candidates to run for election to the Board of Directors in Districts 2, 3, and 8. If you are interested in running, or know someone who may be interested, nominations are currently being accepted for these districts.

**District 2** consists of *Mulligan* and *Albin* townships in Brown County and part of *Nelson* township in Watonwan County. **District 3** is made up of *Lake Hanska* and *Linden* townships and the City of *Hanska* in Brown County, plus parts of *Riverdale* and *Madelia* townships in Watonwan County. **District 8** includes *Ridgley*, *West Newton*, *North* and *South Lafayette* townships, portions of *Cairo* and *Severance*, plus part of *Courtland* townships in Nicollet County.

For each district up for election, a nominating committee is formed with at least two members from that district. Under the

cooperative's bylaws, the nominating committee must, at least 30 days before the Annual Meeting, make a good-faith effort to nominate a minimum of two qualified candidates for each open seat.

Members may also nominate a director candidate by petition. Petitions must include signatures from at least 10 members within the candidate's district. Nominations from the floor and write-in candidates are not allowed at the Annual Meeting.

Members who reside in Districts 2, 3, or 8 and wish to be considered as a director candidate should complete the Director Candidate Application available at [www.browncountyrea.coop](http://www.browncountyrea.coop) before February 20<sup>th</sup>, 2026. Completed applications will be shared with the nominating committee for consideration. Interested members may also contact the REA office for more information.

Director elections will take place at the 89<sup>th</sup> Annual Meeting, scheduled for the evening of April 9, 2026, at the Sleepy Eye Event Center.

## Yes, I'm Interested in Running for BCREA Director

By signing this application, I certify that I am a member of Brown County Rural Electrical Association (REA) and I hereby apply as a nominee for director in District \_\_\_\_\_ and request my name be considered by the Nominating Committee to be placed on the ballot for election at the April 9, 2026 Annual Meeting. I certify that the following statements are true and accurate as to my qualifications to be a candidate for director.

- I am a member in good standing of the cooperative, receiving service at my primary residence, which is in the district where I am seeking election.
- Within the last five (5) years I have not been adjudged to be guilty of a felony.
- Within the last three (3) years I was not an employee of the cooperative or a subsidiary.
- Within the last five (5) years I have not been party in a mediation, arbitration, lawsuit or other legal action against or by the cooperative.
- During the last five (5) years I have not been employed by a labor union which represents or has represented, or has endeavored to represent, any employees of the cooperative.
- I am not a spouse, co-habitant, child, grandchild, parent, grandparent, brother, sister, whether by blood or in-law, of an employee or director of the cooperative.
- I am not in any way employed by or substantially financially interested in an enterprise competing with the cooperative or any cooperative-affiliated business.
- I am not a full-time employee or agent of, nor am I the full-time employer or principal of, another director.
- I have earned a high school diploma or equivalent and I will achieve cooperative director certification or similar certification through NRECA within six years of becoming a director.
- I will notify the appropriate authority of the cooperative in the event that any of the foregoing certification should change prior to the upcoming election or, should I be elected a director, should any of the foregoing certifications not continue to apply to me as serving director of the cooperative.

## All-Expense-Paid Trip to Washington, D.C. for Local Student



Know a high school student who would benefit from an educational trip to our nation's capital? Brown County REA is seeking one outstanding student to represent the cooperative on an all-expense-paid Washington, D.C. Youth Tour, taking place **June 15–20, 2026**.

The Rural Electric Youth Tour brings together approximately 1,500 students from electric cooperatives across the country for a week in Washington, D.C. Participants tour historic monuments, museums, and memorials, spend a day on Capitol Hill, and gain a behind-the-scenes look at how government works.

Students also learn about the cooperative business model, develop leadership skills, and connect with peers from across Minnesota and beyond. The experience offers a unique mix of history, civic exposure, and personal growth, and many participants return home with a deeper appreciation for their community and country.



# Operation Round Up Scholarships Available



Brown County REA, through its Operation Round Up program, is awarding scholarships to high school seniors who plan to attend college following graduation. A minimum of eight \$250 scholarships will be awarded to eligible students whose parent or guardian is a Brown County REA member and resides within the cooperative's service area.

Scholarships are funded through Operation Round Up, a voluntary program in which participating members round their monthly electric bill up to the nearest dollar. The extra change is placed into a trust that is administered by a nine-member board. The board meets quarterly to distribute funds to local charitable

organizations, individuals and families in crisis, and educational scholarships.

Scholarship guidelines and applications are available through area high school counseling offices. Application materials are also available on the REA website at [www.browncountyrea.coop](http://www.browncountyrea.coop).

The application deadline is April 6<sup>th</sup>, 2026. Scholarship recipients will be announced at the Brown County REA Annual Meeting on April 9<sup>th</sup>, 2026. Applicants must submit a copy of their high school transcript and one letter of recommendation. Scholarship funds will be distributed following the successful completion of the student's first semester of college.

## Our Annual Line Patrol is Underway

Brown County REA crews are starting line patrol and will be coming onto yards and property throughout the service area. Line patrol will begin at the far southwest portion of the service territory and will continue to work to the east and north. Work will continue until early spring.

The cooperative patrols its lines each year in the winter months checking the cooperative's overhead and underground lines and equipment. Linemen will be looking for maintenance issues that need attention, such as loose or missing guy wires and guards, damaged wires, and proper line clearance. They will perform maintenance on OCRs and overhead and underground lines.

## ZUPPA TOSCANA RECIPE

### INGREDIENTS

1 lb. ground mild Italian pork sausage

1 onion, finely diced

3 cloves garlic, minced

2 medium russet potatoes, peeled and cubed (about 3–4 cups)

6 cups chicken broth (see notes)

2 stalks of kale, stems removed, finely chopped (2–3 cups)

3/4 cup heavy cream

### DIRECTIONS

**1. Sausage:** Heat oil in a large Dutch oven over medium-high heat. Brown the sausage until fully cooked.

**2. Onions and Garlic:** Add the onions and garlic to the sausage. Sauté for 5–7 minutes until soft and fragrant. FYI your house will smell AMAZING.

**3. Potatoes and Broth:** Add the potatoes and the broth. Simmer for 7–10 minutes, until the potatoes are tender. *(Be careful not to let it go for too long, because the potatoes will start to get really soft.)*

**4. Finish with Cream:** Add the kale and heavy cream. Simmer for 5 minutes until kale has wilted.

**5. Serve:** Season with salt and pepper, top with Parmesan for even more flavor, and dunk into that glorious broth with hot crusty bread.
