Following the Annual Meeting, we held an organizational meeting. Tom Hayes was elected President of the Board, Bill

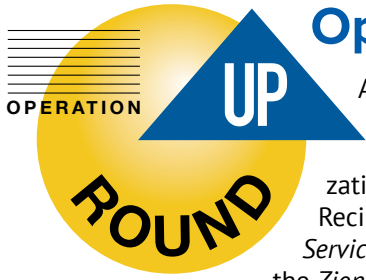


Berg chosen as Vice President, and Jim Hanson elected Secretary-Treasurer. Bill Berg will again represent Brown County REA on the Great River Energy board.

Operation Round Up Trust Board Awards Grants

At an April 7th meeting, the Operation Round Up Trust Board awarded \$1,900 to two organizations and three families in crisis. Recipients included *Lutheran Social Services* meals for Brown County and the *Zion Lutheran Church* food shelf.

Through the generosity of Brown County REA members who participate in Operation Round Up, more than \$273,000 has assisted organizations and individuals in the cooperatives'

service area and provided scholarships to graduating high school seniors. Collectively, your change can make a difference!

Nine Scholarships Awarded to Local Seniors

On April 7th, the Operation Round Up (ORU) Trust Board met and reviewed applications for the ninth annual Brown County Rural Electric Trust scholarships.

This year, nine \$250 scholarships will be awarded to high school seniors whose parents/guardians are Brown County REA members. The winners will receive their funds, to be used for educational costs, after successfully completing one semester at an accredited university, college, vocational, community, or technical college.

Funds for the scholarships come from you, the members, who choose to round up your electric bill to the nearest dollar each month. The difference is placed in a trust which is administered by a nine-member board. The board meets four times each year to distribute funds to charitable causes, individuals and families in crisis, and scholarships. We are grateful to all the members who participate in Operation Round Up.

All the applicants demonstrate leadership in their schools, communities and beyond. When asked to share a most meaningful achievement and how it relates to students' future goals, the answers while diverse, show the compassion and commitment of our area's youth. In addition to community involvement, these young people are active in sports, music, and other extra-curricular activities at their schools while maintaining a rigorous academic schedule. We thank all students who took the time to apply for the scholarships. The quality of applicants again made the selection difficult for trust board members.

CTV Offers 60 Channels for Only \$8 a Month

Requires a UHF Antenna

Looking for low-cost access to TV channels? Want to ditch the satellite dish? Try out CTV, which is owned by four local electrical cooperatives, including yours. What you need is a UHF antenna. Buy one from Walmart or online and install it yourself. Otherwise, reach out to a local TV antenna installer so they can climb the roof and add a booster, splitter, and run the cable; find a list of installers at www.ctv.coop.

CTV operates three towers at Godahl, Jackson, and Frost. "If you are looking for a low-cost TV viewing option, consider CTV," stated Mike Heidemann, CTV general manager. "As an electric co-op member, the CTV charge can be added as a line on your electric bill. Just call or email your co-op to do so. Your \$8 a month helps pay for the tower operations, the maintenance technician, and licensing."

Remembering Former BCREA Board President Gerald Stevens

Former director Gerald Stevens passed away March 30th, 2026. Brown County REA offers its condolences to the family. Stevens served as a Brown County board member for 30 years and was Board President beginning in 1987.

What is the PCA (Power Cost Adjustment) on my Bill?

The Power Cost Adjustment (PCA) is a monthly line item on your electric bill that reflects changes in the cost of wholesale power. Utilities purchase electricity from power suppliers, and those costs can rise or fall based on fuel prices, market conditions, weather, and overall energy demand. Rather than changing base rates each month, the PCA allows those cost increases or decreases to be passed through separately. When wholesale power costs are higher, the PCA may increase your bill. When costs are lower, the PCA may decrease it. The amount is typically based on the number of kilowatt-hours (kWh) used during the billing period, so usage also affects the total.

RHUBARB BARS RECIPE

(Old Fashioned Style, from Laura Fischer's family cookbook)

BOTTOM LAYER

5 tablespoons powdered sugar

½ cup melted butter

1 cup flour

Mix together and press into an 8 × 8 pan.

Bake at 375°F for 15 minutes.

TOP LAYER

2 cups cut rhubarb

2 eggs

1 teaspoon vanilla

1½ cups sugar

½ teaspoon salt

¼ cup flour

¾ teaspoon baking powder

Add all ingredients except the rhubarb together and mix well. Then add the rhubarb.

Pour over the baked bottom layer, then bake at 375°F for 30 minutes.
